First aid measures

Eye contact

Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open. Remove contact lenses after first 5 minutes, then continue rinsing eyes. Seek medical attention.

Skin contact

Take off immediately all contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If symptoms are experienced, move victim to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for

further treatment advice.

Ingestion

Call a poison center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

Protection of first-aiders

Notes to physician

If exposure limits are exceeded or if irritation is experienced, a NIOSH/MSHA approved respirator with an organic-vapor removing cartridge should be worn. Ventilation and other forms of engineering controls are often

the preferred means for controlling chemical exposure.

Hands

Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when

handling chemical products if a risk assessment indicates this is necessary.

Skin

Personal protective equipment for the body should be selected based on the task being performed and the

risks involved and should be approved by a specialist before handling this product. Wear chemical goggles. Use a face shield if splashing is possible.

Methods for cleaning up

Small spill

Ventilate closed spaces before entering. All equipment used when handling the product must be grounded. Floor will be slippery. Do not touch or walk through spilled material. Stop leak if you can do it without risk. A vapor suppressing foam may be used to reduce vapors. Prevent entry into waterways, sewers, basements or confined areas. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers. Use clean non-sparking tools to collect absorbed material.
